I understand the monthly tuition is a bill, and due by the first of each month. If I am late paying (after the 10th) it is subject to **a 10% late fee**. I understand that the school year goes from **Sept thru June**.

There is a **costume fee** due by **Feb** for each dance performed in the June Production.
